## 300 words in support of continuing the SMC Parks Dept's Off-Leash Dog Recreation Program

Have you ever played "Fetch" with a dog? It's the most basic game for dogs. Pretty hard to do when a dog is on leash, though.

I'm sure you agree with American Heart Association and CDC findings that dog ownership typically causes an increase in their owners' physical activity, which helps improve overall cardiovascular health and lowers blood pressure, cholesterol and triglyceride levels. Dog ownership is associated with a 24% risk reduction for all-cause mortality.

But let's make this local. The first time I visited Montara, before moving here in 1997, a big chocolate lab named Riptide was walking alone down 7th Street near Le Conte. A big German Shepherd named Eze used to be dropped off at the Post Office and then he'd lumber up past my house toward his home.

For all the NIMBYs who claim you shouldn't do this or that because it will change the flavor of the Coast, well, dog ownership **IS** part of the culture of the coast. In walking around the hills, trails, streets and schools here I've found very few dog owners who aren't responsible, and they're more than made up for by the many who are.

Dogs add to the quality of life, and we taxpayers appreciate the ability to walk our dogs responsibly off-leash in **specific areas**. Not everywhere, just limited areas in the parks we pay to support and enjoy.

I urge the Supervisors to support their staff, which has reported the positive results of off-leash dog walking. And I'd urge the Supervisors to listen to the many Coastside residents – not the ones from out-of-the-area who show up at the last minute with their own agendas – and continue the Parks Dept's Off-Leash Dog Recreation Program. In fact, I encourage you to use fact-based research to justify expanding the program.
