After reviewing Neil's report from today, I noted that construction activities had started back up again at Lots 9 and 10. I called Bob Pellegrine to confirm, and he informed me that work started onsite on Monday (5/11/2020) of this week. He told me that Tay had come out and conducted a pre-construction survey for biological resources (nesting birds and woodrats) on Monday morning. However, Bob had not received a copy of Tay's report yet. Has the County received a report from MIG to document this survey?
